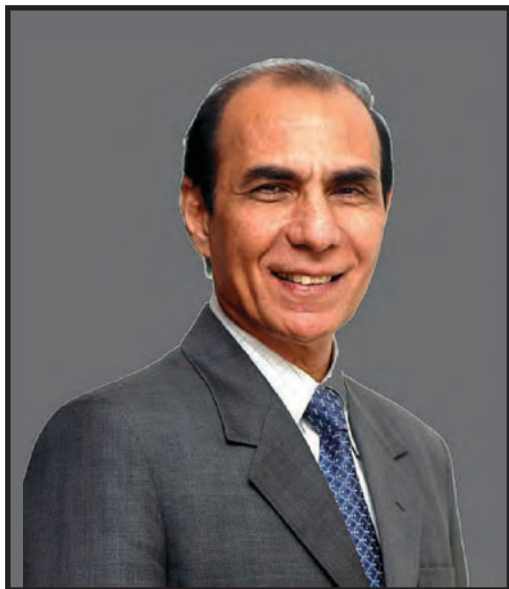

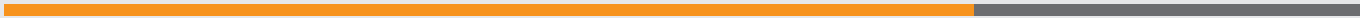

The Second Malaysia-India Strategic Dialogue

This Second Dialogue was jointly organized by ISIS Malaysia and the Indian Council on World Affairs (ICWA). It consisted of:

1. Global views of India and Malaysia – Assessing key strategic, political and economic developments at the international level and the responses of these two nations to global challenges.

The 24th APR, held on 7-9 June 2010, was no exception. Prominent role players included former Australian Minister of Foreign Affairs, the Hon Prof Gareth Evans; former Japanese Deputy Minister of Foreign Affairs, Amb Koji Watanabe; Japan's Special Adviser to the Cabinet on Climate Change & Amb for Global Environment, Amb Mutsuyoshi Nishimura; Head of ASEAN Studies Centre, ISEAS Singapore Amb Rodolfo C Severino; and the co-founder of Centre for Strategic and International Studies (CSIS) Jakarta, Mr Jusuf Wanandi.

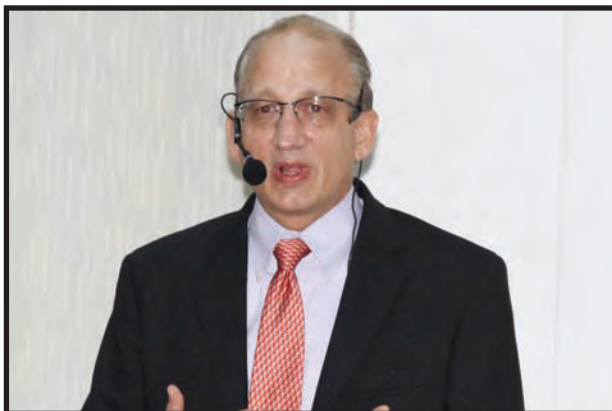

RESEARCH



Projects

As a research institution, ISIS Malaysia undertakes projects and consultancies. Its main projects are listed as follows:

Research and Management of the ASEAN Economic Forum Research Program for the World Bank

ISIS Malaysia was commissioned to study the pattern of the flow of trade in services for ASEAN nations as part of the World Bank's Third Cycle of the ASEAN Economic Forum (AEF). ISIS has the dual role of managing and conducting research for the AEF programme.

Report on 'A Strategic Plan of Action for the Empowerment of MIDA'

ISIS Malaysia was commissioned by MIDA to prepare a report on 'A Strategic Plan of Action for the Empowerment of MIDA.' The key recommendation of the study became a major input for the government policy to corporatize MIDA.

Malaysia's Regulatory, Institutional and Governance System for Managing Foreign Workers

This project was undertaken by ISIS Malaysia together with Prof Azizah Kassim of the Institute of Malaysian and International Studies, National University of Malaysia (IKMAS-UKM). It was part of a World Bank research project to examine Malaysia's policy on foreign workers. The project, which commenced in November 2009, was completed in June 2010.

Services Exports from the Developing World: Lessons for Everyone

This research project, which began in January 2010, focused on the Malaysian services sector. The report was submitted to the World Bank in June 2010.

Report on 'Contextualizing and Localizing Malaysia's Millennium Development Goals (MDG) Report 2010. MDG 8: Develop a Global Partnership for Development'

This project was initiated by the UNDP, in collaboration with the Economic Planning Unit of the Prime Minister's Department to assist in the preparation of the country report on the achievement of the Millennium Development Goals. ISIS Malaysia undertook to study MDG goal no. 8 on global partnership. The research which began in January was completed in July 2010.

Ministry of Science, Technology and Innovation Strategic and Action Plan (MOSTI-SAP) for 2010-2020

ISIS Malaysia submitted Chapter 4.1 'Developing Human Capital in STI towards Generating and Enhancing Knowledge / Innovation-Led Economy' of the MOSTI-SAP. It was also involved in the editing of the submitted chapters for MOSTI-SAP as required under the project agreement. The project commenced in January 2009 and was completed in June 2010.

ASEAN-ISIS - JICA Project Year Two ‘Mainstreaming Human Security in ASEAN Integration’

In March 2010, under the ASEAN-ISIS - JICA Project Year Two, ISIS Malaysia was invited to carry out research in two areas: ‘Environmental Security’ and ‘Assessing the Implementation of the Millennium Development Goals in Malaysia’ as part of the ASEAN-ISIS – JICA Project on Human Security. The studies will be completed by February 2011.

Achieving the ASEAN Economic Community 2015: Challenges for the Malaysian Private Sector

This project was commissioned by the ASEAN Studies Centre of the Institute of Southeast Asian Studies (ISEAS), Singapore. A survey was conducted with the objective of assessing the awareness about the ASEAN Economic Community among corporate players, and identifying the major challenges faced by governments so that recommendations can be made towards attaining the ASEAN Vision 2020. The findings of the report titled ‘Achieving the ASEAN Economic Community 2015: Challenges for the Malaysian Private Sector’ was submitted and presented at a seminar organized by ISEAS on 23 September 2010.

Economic Study of the Development of the National Paddy and Rice Industry Towards Achieving the Objectives of the National Food Security Policy

This study was commissioned by the Economic Planning Unit (EPU), Prime Minister’s Department and was carried out by the Malaysian Institute of Economic Research (MIER). Dr Larry C Y Wong of ISIS Malaysia was engaged as Team Leader of the Study.
