
Message from the Chairman

2011 has been another productive year for ISIS Malaysia, with major noteworthy events. It is with great pleasure and pride that I outline some of them below:

In February, ISIS Malaysia, in collaboration with the International Movement for a Just World (JUST) Malaysia, and the Civilization Studies Center (MEDAM), organized a conference in Istanbul themed **Justice**, **Peace and Dignity**. The keynote speakers were The Hon Prime Minister of Malaysia, Dato' Sri Mohd Najib Tun Razak and The Hon Ali Babacan, Deputy Prime Minister of the Republic of Turkey. The conference and in particular Prime Minister Najib's contribution were widely broadcast by BBC in its World Debate series.

In May, the Asia-Pacific Roundtable (APR) celebrated its 25th anniversary. There was strong international representation and many repeat participants in the APR, making it a leading Track Two meeting on regional security and international relations. Key regional figures and thought leaders who participated included the Indonesian Foreign Minister, Dr Marty Natalegawa; Asean Secretary General, Dr Surin Pitsuwan; and the Commander of the US Pacific Command, Admiral Robert Willard. The Roundtable was officially opened by The Hon Deputy Prime Minister Tan Sri Muhyiddin Mohd Yassin.

Also in May, ISIS Malaysia published the monograph, *Malaysia: Policies and Issues in Economic Development,* which analyses the nation's socioeconomic development since independence. Many notable and eminent experts from the academia, think-tanks, as well as the public and private sectors contributed chapters to this book of nearly 700 pages. HRH Raja Nazrin Shah Ibni Sultan Azlan Muhibbuddin, the Crown Prince of Perak Darul Ridzuan and ISIS



Malaysia Eminent Fellow delivered the opening speech and launched the book.



Asean-ISIS - JICA Project Year Two: 'Mainstreaming Human Security in Asean Integration'

This project which commenced in April 2010 was completed in February 2011. Dr Hezri Adnan, Associate Research Fellow, wrote a paper 'Millennium Development Goals Implementation in Malaysia,' while Wan Portia Hamzah, Senior Fellow, wrote on 'Environmental Security.' All project papers have been published by the Institute for Strategic and Development Studies (ISDS), Philippines.

Asean Monthly Commentary

The Ministry of Foreign Affairs and Trade, Republic of Korea, commissioned ISIS Malaysia to produce the Asean Monthly Commentary (AMC) beginning January 2011. The project which started as a six-month project was extended to December 2011.

The AMC consists of articles on current issues in economics, political and security affairs, within the context of Asean dialogue partners and the Southeast Asian region. Specific topics include Indonesia's priority in its Asean Chairmanship, Myanmar's 2010 elections, the Thailand-Cambodia border dispute, leadership change in Vietnam, the impact of Japan's triple disasters, China's engagement with Asean, the East Asia Summit, the Asean Defence Ministers' Meeting and the future of Asean regional integration.

Asean 2030

This is a background study on Malaysia's major aspirations and challenges for social and economic development in the next two decades, i.e. to the year 2030. The key focus is policy recommendations through which Malaysia can overcome challenges and meet its aspirations, as well as its positioning within Asean, East Asian economic growth and in the broader international context.

Mitigating Food Inflation in Malaysia

ISIS Malaysia submitted a research paper in April 2011 to the Malaysian Government on measures to mitigate food inflation. An updated paper was presented to the Deputy Prime Minister who is the Chair of the Cabinet Committee on Supply and Price.

Joint ISIS Malaysia-CSIS Study: From Strength to Empowerment: The Next Generation of US-Malaysia Relations

ISIS Malaysia and the Centre for Strategic and International Studies (CSIS) embarked on a joint project to study ways of strengthening ties between Malaysia and the US. From this study, recommendations on Malaysia-US relations were presented to the Prime Minister of Malaysia, Dato' Sri Mohd Najib Tun Abdul Razak on 10 November 2011. A full report of the study will be published in early 2012.
