The Institute of Strategic and International Studies (ISIS) Malaysia was established on 8 April 1983 as an autonomous, not-for-profit research organisation. ISIS Malaysia has a diverse research focus, which includes economics, foreign policy, security studies, nation-building, social policy, technology, innovation and environmental studies. It also undertakes research collaboration with national and international organisations in important areas, such as national development and international affairs.

ISIS Malaysia engages actively in Track Two diplomacy, and promotes the exchange of views and opinions at both the national and international levels. The Institute has also played a role in fostering closer regional integration and international cooperation through forums, such as the Asia-Pacific Roundtable (APR), the ASEAN Institutes of Strategic and International Studies (ASEAN-ISIS), the Pacific Economic Cooperation Council (PECC), the Network of East Asian Think-Tanks (NEAT), the Network of ASEAN-China Think Tanks (NACT), the ASEAN-India Network of Think Tanks (AINTT), and the Silk Road Think Tank Network (SILKS). ISIS Malaysia is a founding member of the Council for Security Cooperation in the Asia Pacific (CSCAP) and manages the Council's Secretariat.

As the country's premier think tank, ISIS Malaysia has been at the forefront of some of the most significant nation-building initiatives in Malaysia's history. It was a contributor to the Vision 2020 concept and was consultant to the Knowledge-Based Economy Master Plan initiative. It also produced the first ever National Interest Analysis to be undertaken on Malaysia's participation in the Trans-Pacific Partnership (TPP).

MESSAGE FROM THE CHAIRMAN AND CHIEF EXECUTIVE

The ISIS Malaysia Annual Report 2018, in keeping with previous annual reports, features the activities of the Institute and provides information on the projects, published works, presentations as well as media engagement of our research staff.

ISIS Malaysia remains steadfast in pursuing its objectives of promoting independent research and serious discussions as well as providing timely policy advice on various issues of concern to the nation and the world at large. This has been well achieved through the many conferences, meetings, roundtable discussions and seminars that were organised throughout the year, some of which were done in collaboration with other local and foreign institutions. The year 2018 has been another eventful yet fulfilling year for ISIS Malaysia.

On the front of research projects, ISIS Malaysia continued its study on "An Assessment of China's Belt and Road Initiative on Malaysia". The study aimed to inform policy makers and the public about key policy benefits, costs and risks arising from Malaysia's participation in the Belt and Road Initiative (BRI).

ISIS Malaysia also began collaboration with UNICEF Malaysia on a study entitled "Situation Analysis of Children in Malaysia (SitAn)". The study assesses and analyses the situation with respect to children's rights and development, highlighting potential or critical issues in such areas as legal and policy framework; demographic and socio-economic status; education and child development; health and nutrition; and child protection. The study aims to make a valuable contribution in identifying the trends and key issues especially towards the agenda of child development in Malaysia.

On behalf of the Malaysia National Committee for Pacific Economic Cooperation (MANCPEC), ISIS Malaysia partnered with the New Zealand Pacific Economic Cooperation Council (NZPECC) to lead the Pacific Economic Cooperation Council (PECC) Task Force on Asia-Pacific Economic Cooperation (APEC) Beyond 2020. The Task Force undertook the drafting of a report detailing APEC's achievements to date, key drivers of future growth as well as other challenges and opportunities that lie ahead for the Asia-Pacific region. Its first report, "Towards a PECC Vision for APEC", was produced in 2018.

ISIS Malaysia successfully convened the 32nd Asia-Pacific Roundtable (APR) from 7-9 May 2018. The 32nd APR attracted over 260 participants including ministers, policy makers, security experts, scholars, researchers, journalists and business leaders from the Asia-Pacific, Americas and Europe. The event, which had the full support of the ASEAN-ISIS fraternity as well as other long-time institutional partners, coincided with Malaysia's 14th General Elections, which brought about a change of government in the country. International participants had expressed excitement at being able to witness one of the most momentous events in Malaysia's history at the conclusion of the Roundtable.

In addition to the APR, ISIS Malaysia also organised PRAXIS #GAMECHANGERS 2019 to promote robust and constructive discussions on a wide range of issues spanning economics, business and politics. PRAXIS #GAMECHANGERS 2019 attracted a crowd of economists, politicians, government entities, industry players as well as academics from inside and outside the country. The event was graced by His Royal Highness Sultan Nazrin Muizzuddin Shah Ibni Almarhum Sultan Azlan Muhibbuddin Shah Al-Maghfur-Lah, Sultan of Perak Darul Ridzuan and ISIS Malaysia Royal Fellow. His Royal Highness kindly delivered the Royal Address.

Throughout 2018, ISIS Malaysia held multiple meetings with experts on a number of subject matters. Some of these include a brainstorming meeting on "Strategy and Roadmap to End Child Marriage"; a closed-door meeting on "Cost of Criminalisation vs Treatment for Drug Abuse"; and a strategic meeting on "Promoting the Rights and Well-Being of the Orang Asal in the Era of the Sustainable Development Goals (SDGs)". Moreover, ISIS Malaysia maintained its tradition in organising roundtables on various issues. Among those were "Artifical Intelligence in Healthcare – International Developments and Opportunities for Malaysia"; "Mid-Term Review – Eleventh Malaysia Plan"; and

CHD-ISIS Dialogue on "Managing Philippine-Malaysia Migration in Sabah".

On 28 November 2018, ISIS Malaysia was honoured to host The Honourable Dato' Saifuddin Abdullah, Malaysia's Minister of Foreign Affairs. ISIS Malaysia Board Members and staff were also present to welcome The Honourable Dato' Saifuddin on his first visit to ISIS Malaysia as Minister of Foreign Affairs.

The Institute was also able to host prominent leaders, policy makers, legislators, diplomats and scholars who spoke on a variety of subjects through our ISIS International Affairs Forum (IIAF) series. These speakers included Prof Emeritus Dorodjatun Kuntjoro-Jakti, Indonesia's former Coordinating Minister for Economic Affairs; HE Merve Safa Kavakci, Ambassador of the Republic of Turkey to Malaysia; General Zubair Mahmood Hayat, Chairman Joint Chiefs of Staff Committee (CJCSC) of Pakistan Armed Forces; Mr Tamim Madani, Charge d'affaires of the Embassy of Syria in Kuala Lumpur; Dr Shashi Tharoor, Chairman of the Parliamentary Standing Committee on External Affairs, India; HE Andrew Goledzinowski AM, High Commissioner of Australia; Professor David Shambaugh, Gaston Sigur Professor of Asian Studies at George Washington University; Dr Chanintira Na Thalang, Associate Professor of International Relations at Thammasat University; Mr Hugh Peyman, author of *China's Change: The Greatest Show on Earth;* Prof Wongi Choe, Professor and Head of Center for ASEAN-Indian Studies at Korea National Diplomatic Academy; and Air Commodore Bill Boothby (Retd), Associate Fellow at Geneva Centre for Security Policy. Several roundtable discussions were held on diverse areas of interest, featuring speakers from different institutions and countries. In addition, ISIS Malaysia continued to receive visitors from various institutions and organisations in Malaysia and overseas.

ISIS Malaysia continues to actively engage and maintain close links with other think tanks and institutions at home and abroad. The Institute jointly hosted in Malaysia several events with think tanks and institutions from other countries. These included the 49th Council for Security Cooperation in the Asia Pacific (CSCAP) Steering Committee Meeting; a Task Force Meeting for the PECC Structure Project on "Asia-Pacific Economic Cooperation (APEC) Beyond 2020", jointly chaired by the MANCPEC and the NZPECC; the Second Malaysia Scholars on Korea (MASK) Network Seminar on "Recent Events in the Korean Peninsula and Implications for Republic of Korea-Malaysia/ASEAN Relations", co-organised with the Embassy of the Republic of Korea in Malaysia; a meeting on "Constructing Multilayered Communication Channels Between Korea and ASEAN", held in collaboration with the Korean Association of International Studies (KAIS) and Korea Foundation (KF); and the Valdai Club Asian Regional Conference, a first ever collaboration between ISIS Malaysia and the Moscow-based Valdai Club.

ISIS Malaysia also organised and coordinated long-standing annual events – the 7th Malaysian-German Security Dialogue, held in partnership with Konrad-Adenauer-Stiftung (KAS), and the 11th ASEAN-Australia-New Zealand (AANZ) Dialogue, organised jointly with Asialink and the Asia New Zealand Foundation.

Pursuant to the MOU signed in November 2015, an ISIS Malaysia delegation visited Kunming and Nanning, People's Republic of China, in September 2018 at the invitation of the Chinese Academy of Social Sciences (CASS). Both institutes participated in the China-Malaysia Strategic Cooperation Forum, which explored ways to achieve win-win outcomes from the BRI. The delegation also met with Yunnan University and Guangxi University as well as visited the China-Malaysia Qinzhou Industrial Park.

ISIS Malaysia also hosted a delegation from the Chinese People's Institute of Foreign Affairs (CPIFA) between 29 November and 1 December 2018. The main purpose of the visit was to convene the 4th China-Malaysia Seminar. Furthermore, the delegation had a discussion on the current state of Malaysia-China bilateral relations with YM Dato' Raja Nushirwan bin Zainal Abidin, Deputy Secretary General (Bilateral Affairs) at the Ministry of Foreign Affairs Malaysia.

As in the past, ISIS Malaysia's Chairman and Chief Executive and research staff attended numerous conferences, seminars and colloquia at home and abroad, including the Maritime Security Study Group in Tokyo, January 2018; Effects of Digitalisation on Society and Politics in Asia and Germany in Berlin, March 2018; CSIS Global Dialogue and the 25th PECC General Meeting in Jakarta, May 2018; the 18th Melaka International Youth Dialogue (MIYD) in June 2018; the IISS Shangri-La Dialogue in Singapore, June 2018; the 7th World Peace Forum in Beijing, July 2018; the International Symposium on APEC Post-2020 Vision and Asia Pacific Regional Integration in Sanya, September 2018; and the 15th Annual Meeting of the Valdai Discussion Club in Sochi, October 2018.

I wish to record here that the accomplishments attained by ISIS Malaysia would not have been possible without the support, assistance and encouragement of the Government of Malaysia and other governments as well as various individuals and organisations, public and private, here in Malaysia and abroad. I wish to express my sincere appreciation and gratitude to all our friends, associates and supporters for their invaluable assistance and generous contributions that enabled ISIS Malaysia to carry out its activities throughout the year.

I would also like to record my appreciation to the members of the Board of ISIS Malaysia for their full support and encouragement. Last, but not least, I thank and commend all staff for their dedication and commitment in ensuring that ISIS Malaysia remains as the nation's premier think tank.

I look forward to continued success and greater achievements in the coming year for ISIS Malaysia.

EVENT HIGHLIGHTS

ISIS Malaysia was actively involved in the organisation as well as collaboration of numerous conferences and meetings in 2018. This section highlights six major conferences, one National Affairs Forum (NAF) and a series of ISIS International Affairs Forum (IIAF). ISIS Malaysia also conducted a number of roundtable discussions and hosted a number of meetings with experts and diplomats. A special visit by Malaysia's Minister of Foreign Affairs is also highlighted in this section. Additionally, there were visits by institutions from several countries, including Iran, Pakistan, India, Kuwait, Japan, Singapore, Norway, Germany, Republic of Korea, People's Republic of China, and the United States. Hilton Kuala Lumpur, 7-9 May 2018

The 32nd Asia-Pacific Roundtable (APR) was convened from 7-9 May 2018 amidst the 14th Malaysian General Election (GE14). Despite the challenges posed to the organiser, the participants of the APR were generally excited to experience and witness events surrounding the historic Malaysian election that saw a peaceful change of government.

The 32nd APR, attended by about 200 participants, was officiated by U Khin Maung Lynn, the Joint Secretary of the Myanmar Institute of Strategic and International Studies (MISIS). U Lynn delivered the Opening Remarks on behalf of the Chairman of MISIS. The Welcoming and Closing Remarks were delivered by ISIS Malaysia's Tan Sri Rastam Mohd Isa, Chairman and Chief Executive of ISIS Malaysia.

Prominent role players included Ambassador Pou Sothirak, Executive Director, Cambodian Institute for Cooperation and Peace (CICP), Cambodia; YM Raja Dato' Nushirwan Zainal Abidin, Deputy Secretary General (Bilateral Affairs), Ministry of Foreign Affairs, Malaysia; Mr Siddharth Varadarajan, Founding Editor, The Wire, India; Professor Tosh Minohara, Professor of US-Japan Relations, Kobe University, Japan; Mr Walter Lohman, Director, Asian Studies Center, Davis Institute for National Security and Foreign Policy, The Heritage Foundation, USA; Professor Xiang Lanxin, Professor, International History and Politics, The Graduate Institute Geneva, Switzerland and Director, Centre of One Belt and One Road Studies, China National Institute for SCO International Exchange and Judicial Cooperation, China; Dr Iftekhar Ahmed Chowdhury, Principal Research Fellow and Research Lead, Institute of South Asian Studies, National University of Singapore, Singapore; Dr Thitinan Pongsudhirak, Director, Institute of Security and International Studies (ISIS) Thailand, Thailand; Professor Dr Aileen SP Baviera, President Asia Pacific Pathways to Progress, the Philippines; Mr Timofei Bordachev, Programme Director, Valdai Discussion Club, Russia; Professor Dr Dewi Fortuna Anwar, Chairman, Institute for Democracy and Human Rights, The Habibie Center, Indonesia; Dr Lee Jaehyon, Senior Fellow, ASEAN and Oceania Studies Program, the Asan Institute for Policy Studies, Republic of Korea; Professor Dr Nguyen Vu Tung, President, Diplomatic Academy of Vietnam (DAV), Vietnam; Dr Ayman Khalil Director, Arab Institute for Security Studies, Jordan; Professor Natasha Hamilton-Hart, Director, New Zealand Asia Institute, University of Auckland, New Zealand.

The 32nd APR was structured with four Plenary Sessions and six Concurrent Sessions. The theme of the four Plenary Sessions were Politics in Southeast Asia: Change or Status Quo?; America First, China Rising: A New Global Order?; Innovating ASEAN, Preserving Resilience; and The State of the Region: The Future of APEC and Regional Economic Partnership Arrangements. The six Concurrent Sessions covered strategic updates on Northeast Asia, West Asia, South Asia and Central Asia, as well as sessions on Technology and the Battlefield: The Evolving Nature of Warfare and Future-Proofing Against Violent Extremism. In addition, there was a Special Panel on Foreign Policy on the Digital Age. A key difference at this year's APR was the introduction of "Instigators" instead of "Moderators" to better navigate the conference sessions. The move was generally well received by both role players and attendees.

PRAXIS #GAMECHANGERS 2019

Sheraton Imperial Kuala Lumpur Hotel, 4 October 2018

PRAXIS #GAMECHANGERS 2019 was ISIS Malaysia's premiere economic conference. 

The Institute routinely undertakes research and consultancy projects at any one time. Some of the projects, which started in the previous year, were continued in 2018.

An Assessment of China's Belt and Road Initiative in Malaysia

Situation Analysis of Children in Malaysia Research staff embarked on a study to conduct an assessment of China's Belt and Road Initiative (BRI) in Malaysia in September 2017. The study was not a mere assemblage of information or personal opinions, but critically researched, evaluated and debated to reach robust objective conclusions. It addressed the themes and live concerns that were being discussed in the public arena.

In the study, Malaysia's national interest is defined as the policies, action and conditions needed for the nation's wellbeing in the following spheres: (i) political, diplomatic and security; (ii) economic, business, trade and investment; and (iii) social and cultural. The study aims to inform policymakers and the public in a clear and concise manner about key policy benefits as well as costs and risks arising from Malaysia's participation in the BRI. The study was concluded in August 2018.

At the invitation of the Ministry of Finance Malaysia, the Economics, Trade and Regional Integration (ETRI) division offered its views and recommendations to assist the former's endeavour in drafting the Budget 2019. The study project ran from 12 to 29 June 2018, which concluded in the submission of a memorandum to the Ministry via its dedicated Budget 2019 website at https://budgetconsultation.treasury.gov.my.

The Malaysia National Committee for Pacific Economic Cooperation (MANCPEC), together with the New Zealand Pacific Economic Cooperation Council (NZPECC), is leading the work of the Pacific Economic Cooperation Council (PECC) Task Force on Asia-Pacific Economic Cooperation (APEC) Beyond 2020. The Task Force was tasked specifically to draft a report detailing APEC's achievements to date, key drivers of future growth as well as other challenges and opportunities that lie ahead for the Asia-Pacific region. The Task Force produced its first report titled "Towards a PECC Vision for APEC" in 2018 and has presented findings of the project at APEC and APEC-related meetings in 2018. The Task Force is expected to produce the second report titled "The PECC Vision for APEC" by 2019.

UNICEF Malaysia and ISIS Malaysia have embarked on a study entitled "Situation Analysis of Children in Malaysia (SitAn)". A SitAn is a synthesis of statistics, national policies, legislation and trends, and research and analysis. It assesses and analyses the situation with respect to children's rights and development, highlighting potential or critical issues in the following areas: legal and policy framework; demographic and socio-economic status; education and child development; health and nutrition; and child protection. Experts have been commissioned to research the situation of children in each of these sectors, with numerous meetings, workshops and consultations organised to engage with stakeholders from the government, civil society, academia, private sector and others.

To be completed in July 2019, UNICEF and ISIS Malaysia expect this study to make a valuable contribution in identifying the trends and key issues, especially towards the agenda of leaving no child behind, and towards Malaysia's development goals.






